Rules of Thadjmaïth 'ELKHIR' procedures

Adopted by the board of directors

Preamble

This document is adopted by the Board of Directors, it specifies the internal rules of the Association.

Article 1: Membership

- 1.1 Any new member is subject to an application for membership, to do so, he or she must complete a form via our website "elkhir-usa.org".
 - 1.2 he will pay the annual membership fee fixed by the assembly, membership fee must be paid at the beginning of each year over a period of one month
 - 1.3 Failure to respect a member's contribution will result in no coverage from the association.
 - 1.4 the amounts of contributions and entry fees are set by decision of the board of directors as follows:
 - \$ 100 single person.
 - \$ 150 married without children.
 - \$ 200 married with child or more.
 - 1.5 the amounts of contributions may be reviewed by vote of all members, (General Assembly) transcribed in minutes and brought to the attention of those concerned by any means.
 - 1.6 Any visitor to the family member have the right to contribute to the association.
- 1.7 The association will not support family members of members living in the USA who are not declared.
- 1.8 the payment of the contribution will be made by internet.

- 1.9 Membership of the association is open to anyone resident in Kansas and Missouri only.
- 1.10 Any contribution paid to the association is definitively acquired, no refund can be required in the event of resignation or exclusion.
- 1.11 Withdrawal from membership after the stipulated deadlines will be subject of loss of the rights.
- 1.12 In the event of the death of a member occurring outside the states of Kansas or Missouri, the association will only support financially the deceased.

• **Article 2: Activity of the association**

- 2.1 Death of a member:
 - Take charge, organize, pay the burial or repatriation costs of the deceased to Algeria.
 - Support the bereaved,
 - An aid dedicated to the family of the deceased, who died only outside the USA, of the amount of \$ 500.

Article 3: Modification of the internal regulations.

A proposal to modify the regulation can be introduced by

- Board of directors.

Article 4 - Resignation - Exclusion

- 4.1 The resignation of an active member of the association must be addressed to the board of directors of the council by letter or email. .
- 4.2 the exclusion of a member may be pronounced by the council, for serious reasons or for abstaining from the payment of fees.

Article 5 General meetings.

- 5.1 The board of directors draws up the agenda for the meeting which will be communicated to the members.
- 5.2 If a member of the association cannot attend a meeting in person, he may be represented by a proxy.

- 5.3 The General Assembly will be held at the beginning of the month of may,
The exact date and time will be communicated.

Article 6: Financial provisions

The association's resources come from:

- Membership fees.
- Subsidies from public or private entities.
- Aid from external entities.

Article 7: Election of officers

The election of members generally takes place through the General Assembly. Voting will be done freely by direct means.

- The elected officers work for a term of 04 years.
